

## ARCOMA Code of Conduct

Current and future success is grounded in our collective commitment to live our values.

At the foundation of these values is total, unyielding integrity. We are committed as an organization to the highest ethical standards and compliance with all applicable laws, rules and regulations. Our reputation for honesty and reliable business conduct is tested and proven in everything we do. We operate in a heavily regulated industry, where even the best intentions can lead to promises that cannot be kept or, even worse, damage our company's name, reputation and credibility.

Therefore, all of us who represent Arcoma in any position or capacity must be personally committed to follow the letter and the spirit of our Code of Conduct. All Arcoma leaders have the additional responsibility of nurturing a culture in which compliance with this Code is constant and unwavering.

It is, and must be, the way we work. Unethical, dishonest and questionable behavior will not be tolerated.

## General principles

### THE ARCOMA GROUP SHALL:

- comply with the laws and regulations of each country in which it operates
- demonstrate and promote its commitment to responsible business practice in policies, decisions and activities
- integrate the principles of this policy into critical processes.

### REQUIREMENTS ON BUSINESS PARTNERS

The Arcoma Group prefers to work with component suppliers, consultants, distributors and other business partners that share the principles expressed in this Code of Conduct.

The Arcoma Group encourages its business partners to apply standards of business conduct consistent with the principles of this Code of Conduct.

## **Business principles**

### ACCOUNTING AND REPORTING

All financial transactions shall be reported in accordance with generally accepted accounting practices, and the accounting records must show the nature of all transactions in a correct and non-misleading manner.

The Arcoma Group shall report in a transparent, truthful and timely manner with the aim of conveying a true view of the Arcoma Group's performance.

### **COMPANY PROPERTY AND RESOURCES**

The Arcoma Group's property and resources shall be used for business objectives.

The property and resources shall not be used for personal gain, fraudulent purposes, or in any other inappropriate manner.

### **TAXATION**

The Arcoma Group shall comply with the tax laws and regulations of each country in which it operates. Where tax laws do not give clear guidance, prudence and transparency shall be the guiding principles.

### **CUSTOMER OFFERING**

The Arcoma Group shall ensure that its products meet all applicable regulatory requirements.

The Arcoma Group shall design its products with a focus on our core values of quality, safety and environmental care.

### MARKETING AND SALES

The Arcoma Group shall present its products and services accurately and shall comply with applicable regulatory and legal requirements.

The Arcoma Group shall not make false statements or provide misleading information regarding its products or their performance, including the safety and environmental attributes of the products.

All products and services and technology must be transferred with the export and import law requirements in the countries in which we operate. Products must be classified and export licenses must be obtained.



### **FAIR COMPETITION PRACTICES**

The Arcoma Group shall compete in a fair manner and with integrity.

The Arcoma Group shall not exchange information or enter into agreements or understandings with competitors, customers or suppliers in a way that improperly influences the market place or the outcome of a bidding process.

The Arcoma Group shall use legitimate methods to gather information about our competitors.

### **ANTI-CORRUPTION**

The Arcoma Group shall not participate in or endorse any corrupt practices.

Representatives of the Arcoma Group shall not offer customers, potential customers, suppliers, consultants, governments, agencies of governments, or any representative of such entities, any rewards or benefits in violation of applicable laws or established business practices stricter than applicable laws, in order to obtain or retain business or to gain any other improper advantage.

Arcoma Group employees shall not accept payments, gifts or other kinds of reimbursement from a third party that could affect or appear to affect their objectivity in their business decisions.

### MONEY LAUNDERING

The Arcoma Group shall not accept, facilitate or support money laundering.

### **CONFLICTS OF INTEREST**

All representatives of the Arcoma Group shall conduct their private and other external activities and financial interests in a manner that does not conflict or appear to conflict with the interests of the Group.

Employees' private interests shall not influence, or appear to influence, their judgement or actions in performing their duties as representatives of the Group.

### POLITICAL INVOLVEMENT

The Arcoma Group shall observe neutrality with regard to political parties and candidates for public office. Neither the names nor the assets of Arcoma Group companies shall be used to promote the interests of political parties or candidates for public office.

## Principles investor information

### INSIDER TRADING

Arcoma Group employees who have access to non-public information that may affect the Arcoma share price are not allowed to buy or sell Arcoma shares or any other financial instruments that relate to the Arcoma share, such as futures or options. In addition, he or she may not induce anyone else, by giving advice or in some other manner, to undertake such trading.

# Principles of human rights and social justice

### **HUMAN RIGHTS**

The Arcoma Group shall support and respect the protection of internationally proclaimed human rights and make sure the Group is not complicit in human rights abuses.

### NON-DISCRIMINATION

All employees shall have equal opportunities based on competencies, experience and performance regardless of gender, race, religion, age, disability, sexual orientation, nationality, political opinion, union affiliation, social background or ethnic origin.

All employees shall be treated with respect. Discrimination, physical or verbal harassment, or any illegal threats are not tolerated.

### WORKPLACE PRACTICE

The necessary conditions for a safe and healthy work environment shall be provided for all Arcoma Group employees.

#### FORCED LABOUR

The Arcoma Group shall not engage in or support forced, bonded or compulsory labour, nor shall the Arcoma Group require any form of deposit or confiscate identification papers from employees.

Employees are free to leave their employment after reasonable notice as required by law and contract.

### **CHILD LABOUR**

Child labour is not tolerated. The minimum employment age is the age of completion of compulsory school, but never less than 15 years.

### FREEDOM OF ASSOCIATION

The Arcoma Group respects the right of all employees to join an association to represent their interests as employees, to organize and to bargain collectively or individually. The Arcoma Group shall respect the recognized unions. An employee's right to refrain from joining a union is equally respected.

The Arcoma Group shall notify employees' representatives and relevant government authorities, of major changes in our operations as required by law.

### WORKING HOURS AND COMPENSATION

The Arcoma Group shall comply with applicable laws, agreements and industry standards on working hours and compensation.

## **Environmental principles**

### RESOURCE EFFICIENCY

The Arcoma Group products and processes shall be designed in such a way that energy, natural resources and raw materials are used efficiently, and waste and residual products are minimized.

### PRECAUTIONARY PRINCIPLE

The Arcoma Group shall avoid materials and methods posing environmental and health risks when suitable alternatives are available.

Particular emphasis shall be put on evaluating the potential risks of present and future substances and operations in order to minimize the negative impact on the environment.



## Responsibility for compliance

It is the responsibility of the Arcoma Group managers to implement this policy and inform their employees of their rights, duties and responsibilities as well as demonstrate the content and spirit of this document within their respective organization. It is the responsibility of all employees to comply with local law and the Arcoma Group policies. Explicit or implicit approval of questionable actions that are in conflict with the Code of Conduct will not be tolerated and may result in disciplinary actions up to and including dismissal and legal proceedings.

### **Deviations**

Deviations from this policy may be approved only by Arcoma AB Board of Directors.

### Periodic review

The issuer of this document, being the Board of Directors of Arcoma AB is responsible for ensuring that a review of the document is performed every year.

## Report on violation of the Code of Conduct

All employees within the Arcoma Group are encouraged to report suspected violations of this Code of Conduct to their direct superiors or the managers of their superiors. In the event a report is not taken seriously, or if an employee does not feel comfortable reporting the matter to his or her superior, the employee should escalate the matter to the chairman of the board of directors.
